

ASWEAS Annual Reporting

The Australian Social Work Education and Accreditation Standards (ASWEAS) require Social Work Academic Organisation Units (SWAOU) providing AASW Accredited Social Work qualifications to report annually on the status of their accreditation program. Annual reporting allows SWAOU and the AASW to:

- have an accurate picture of the current status of programs;
- identify opportunities to work together; and
- contribute to an accurate picture of the current status of Social Work education to promote to Government and Industry.

Annual reporting must be completed each year - even in the year of an accreditation review.

About the report document:

The report is a PDF document, which you can complete, save and submit electronically. Please ensure you save the document before you start to complete. Document should be saved and submitted with the following details: 'HEP name' and 'AASW annual report year'.

The Report is made up of two sections: part one for Bachelor of Social Work programs; part two for Master of Social Work programs. If your SWAOU does not offer a program at both levels please specify by typing None at the top of the relevant section.
